## 2.0 Meeting Notes – December 9-10

#### Welcome, Introductions, and Agenda

Chris Craig, Florida Department of Transportation (FDOT), welcomed attendees to the Florida Occupant Protection Coalition (FOPC) meeting and thanked everyone for joining. He asked attendees to introduce themselves, reviewed the agenda and began the meeting.

#### **Member Recognition**

Chris said Carol Mazzocco, Kidz In Motion Inc, will be retiring at the end of December 2020. He thanked her for her participation on the Coalition and her service to the child passenger safety (CPS) subcommittee since 2019. Carol was not present at the meeting. Chris wished her well on her retirement.

#### **FOPC Strategic Action Plan Update (2021)**

Leilani Gruener, FDOT, reminded participants that the current FOPC Strategic Action Plan ends this year and is scheduled to be updated following the adoption of the Florida Strategic Highway Safety Plan (SHSP) and completion of the Occupant Protection (OP) Assessment early next year. She presented the four proposed revised goals to include in the upcoming FOPC Action Plan revision and reminded participants about the discussion on the proposed goals from the previous meeting.

- Goal 1: Establish a sustainable infrastructure that provides leadership, funding, data, policy and evaluation for occupant protection.
- Goal 2: Establish a collaborative effort to provide statewide direction and focus to improve law enforcement awareness of occupant protection.

- Goal 3: Establish a collaborative effort to provide statewide direction and focus for child passenger safety.
- Goal 4: Establish a collaborative effort to provide statewide direction and focus for occupant protection for low use groups.

Leilani noted in the proposed structure, the Education/Communication/Outreach goal (Goal 1 of the existing action plan) would be incorporated in each of the proposed goals to help reduce duplication across several goals/objectives. She also noted that OP for low-use groups (e.g. males ages 18-34, pickup truck drivers, minority population) is proposed for inclusion in the updated FOPC Action Plan to prioritize safety belt usage in the action plan. She asked members if there were any concerns with identifying low use groups specifically.

Coalition members had the following questions and comments:

- Consider adding e-bikes, golf cart as sub-categories along with other low use groups.
  - Leilani responded these sub-categories will not align with the OP grant and are considered by other coalitions.
- The OP for low-use group will also consider air bags, something that is not discussed in other goals.
- Should this subcommittee be driven by the categories or safety belt usage in the Action Plan?
  - We have the flexibility to address any issue on low-use groups as we review our Action Plan status and have an understanding on safety belt usage by this groups.
- We have identified low-use groups but some counties have higher fatality and serious injury rates among low-use groups. Should we expand this goal to include low-use locations as well throughout the state?
  - It could be as broad as rural vs urban or regional vs county. Day time vs nighttime could be another option to consider for low use.
- Do we want to lower the age group as 16-34 on the statewide safety belt use?
  - Chris said the age breakdown comes from the national guideline and the number also corelates with trauma center data on injuries.

#### **OP Assessment Update**

Chris gave an update on the OP Assessment. He reminded participants that the coalition requested the National Highway Traffic Safety Administration (NHTSA) conduct an OP assessment and NHTSA will start the process at the beginning of 2021. He said that assessments are normally done in person but this year the procedure will be done virtually due to the pandemic. He is meeting with the lead assessor this week and will provide additional instructions on the assessment prior to the next meeting.

Coalition members had the following questions and comments:

• Robert Chaffe, Preusser Research Group, offered to help the assessment and any associated data needs.

#### **Legislative Update: Safety Belts and CPS Restraints**

Danny Shopf, Cambridge Systematics, reviewed an early draft of the model language regarding Safety Belt Usage and CPS restraints which was revised based on the comments received at the past meeting. He asked members for their feedback to help finalize the model language to get these posted to the website.

Coalition members had the following questions and comments:

#### Safety Belt Usage (Florida Statute 316.614)

- Need to work on subsection 8. This would be a good place to add a reference to the operator getting the ticket if someone under 18 is not restrained.
- Suggest changing "Safety belt" to "Seat belt".

#### CPS Restraint Law (Florida Statute 316.613)

- Danielle Kessenger, The PLAYERS Center for Child Health and Wolfson Children's Hospital, noted Louisiana CPS law<sup>1</sup> is the most recently updated law and very easy to understand and explain to caregivers. She also shared a document showing restraint use against child age/size<sup>2</sup> based on the Louisiana CPS law.
- Danny noted Louisiana CPS law (subsection 5) requiring all children under 13 years old to ride on the rear seat is suggested in the draft model language, as discussed in the past meeting.
  - Edit the language to include "unless the number of children exceeds the number of seats available in the back".
- Subsection 2.a. of the current Florida CPS statute conflicts with F.S. 316.6145<sup>3</sup> (School buses; safety belts or other restraint systems required) that says busses manufactured after a certain date need to be equipped with safety belts. This could be a rationale to suggest an update to this statute.
  - Safety seats are not tested on golf carts. Add "golf carts" in subsection 2.e.
- Increasing the age limit for booster seats would be beneficial for Florida. For subsection 1.a. recommend using 12 years of age or younger and see the response from legislators.
  - Consider using the Louisiana CPS law format for child age requirement. For instance, "....a child who has reached/surpassed X age or the height/weight requirements set by the manufacturer....".
- Can also review this source State Laws for Child Safety Seats in Rideshare vehicles<sup>4</sup>

Danny updated the draft model languages on-screen and reminded participants that Patty Turner, University of Florida, shared the draft legislative documents with the Coalition members before the meeting. He asked members to provide additional feedback over the next two or three weeks.

#### **SHSP Update**

Chris noted the Coalition members reviewed an early draft of the SHSP few months ago and shared their input. He asked Danny to provide an update of the revised SHSP. Danny said FDOT and staff addressed the comments received through various coalitions and safety partners and shared a high-level overview of different sections of the latest SHSP with the coalition. He asked members to share any input or concerns.

Coalition members had the following questions and comments:

- Do we need to consider revising "Safety Belt" if we are providing revised model language.
  - Change "Safety Belt" to "Seat Belt" on Pages 34 and 35 of the plan. Do a full review of the document for "seat belt".

- Page 35: Change "Car seat Installment" to "Child Passenger Safety" and "CarFit Program" to "CarFit" only.
  - Consider adding a logo for CPS as well, or removing CarFit logo for balance on Page 35.
- Do we have any action item or indicators to measure safety belt use trend among law enforcement (LE) officers.
  - We have done the LE survey on seat belt uses that would measure the progress.

Chris said Leilani will send out the updated SHSP to all the members. The email will include a link to share comments in detail by December 23, 2020.

#### **Subcommittee Groups Update**

Fran Carlin-Rogers, CarFit, said that while the national CarFit programs have been cancelled due to the pandemic, CarFit is planning on a return in March 2021. Currently, CarFit programs are being conducted virtually with opportunities for focused sections for people who have specific questions.

#### **Public Comment**

There were no comments from the public.

### 3.0 Action Plan Implementation – Group Breakouts

Three separate virtual meetings were conducted for each of the three group breakout sessions- Education, Communication, and Outreach; Law Enforcement; and Occupant Protection for Children.

The following sections include meeting notes from the three breakout sessions. A revised FOPC Action Plan is attached as an Appendix of this summary report and can also be found at <a href="https://www.floccupantprotection.com">www.floccupantprotection.com</a>.

#### Strategic Action Plan Goal 1 – Education, Communication, and Outreach

Subcommittee members conducted a breakout session on December 10, 2020, to discuss activities they have been working on since the last FOPC meeting and review their section(s) of the FOPC Action Plan. Danny updated the Action Plan on-screen.

Coalition members had the following questions and comments:

- David Summers, Trauma Agency, Health Care District Palm Beach County is working on pickup truck information to develop educational materials.
- FOPC will be shifting from the Occupant Protection Resource Center (OPRC) to the Traffic Safety Resource Center,
   a one-stop shop for safety materials developed by all of Florida's safety coalitions.
  - Would like to see the new resource center focus more on design of original or adapted materials and providing digital copies of those materials.
- Would partner agencies be allowed to add their logo to some of the digital resources available on the website?
  - The materials Florida produces and owns are able to be customized to include partner logos.
- There would be value in adding a preview of the materials on the website for people to know what they are ordering.
- Are most people ordering from desktop or mobile platforms?

- The updated resource center is being designed to function across multiple browsers and devices. We will
  be able to track that down once we move to the new platform.
- Andrea Atran, FDOT District 2, and David reviewed the materials on the OPRC website and shared the following feedback:
  - Need to fix the dead links on downloadable materials.
  - Andrea liked the Prom poster but does not see much value in the other posters. Unsure of the audience of these posters. Some of the books do not actually mention the target age of children, which would be helpful to know before ordering.
  - Danielle Kessenger noted the I'm Safe<sup>5</sup> website mentions the target age for the resources. Andrea shared the District 2 Traffic Safety Resources<sup>6</sup> website.
  - The materials were developed across various timeframes, thus felt disjointed. Andrea prefers ordering only what you need for the year and then updating materials to ensure a consistent and cohesive style.
- Consider reviewing assessments from other states to see if there are opportunities to identify strategies to address some of the gaps in our own assessment.
- Leilani mentioned that NHTSA developed a CPS Week Guide 2018<sup>7</sup>. She asked if members of this subcommittee would be interested in developing a CPS week guide for Florida particularly to be used by stakeholders.
  - This can be developed in coordination with the CPS subcommittee.
- Would like to incorporate a reference to Saved By the Belt as a pre-built program to recognize good behavior.
  - Leilani will follow up with Melissa Valido, Florida Teen Safe Driving Coalition, to see if they have insight on a digital battle of the belts format.
- Patty said there is a lot of repositioning happening across various partner institutions, we might need to reach out to potential new members.
- Comments regarding Action Plan:
  - Follow up with Michael Binder, University of North Florida, on the OP outreach survey (Action Item 1.1C)
     for 2021 and see if there is value in adding a few questions about adjustments made due to COVID.
  - Action Item 2.1D- Preusser Research Group can summarize some content to put together based on their initial research.

#### Strategic Action Plan Goal 2—Law Enforcement Awareness of Occupant Protection

Subcommittee members met for their breakout session on December 10, 2020, to discuss activities they have been working on since the last FOPC meeting and review their section(s) of the FOPC Action Plan. Danny updated the Action Plan on-screen.

Coalition members had the following questions and comments:

• Tim Roberts, Florida Law Enforcement Liaison (LEL) Program, reported around 64,000 OP reference cards were distributed. The LEL subcommittee will present at the next FOPC meeting to show the distribution plan, as well as

other occupant protection materials that have been delivered. Tim will start sharing these with the other members of the coalition but not sending to the public.

• Leilani asked if FDOT were able to offer OP mini grants to LE agencies, would that encourage agencies to participate in the Click it or Ticket (CIOT) campaign.

#### Strategic Action Plan Goal 3—Occupant Protection for Children

Subcommittee members met for their breakout session on December 9, 2020, to discuss activities they have been working on since the last FOPC meeting and review their section(s) of the FOPC Action Plan. Danny updated the Action Plan on-screen.

Coalition members had the following questions and comments:

- Amy Artuso, National Safety Council, said Florida did a great job distributing tablets for digital car seat checks and thanked the coalition for their efforts in this distribution.
  - Patty asked for guidance on what kind of data should be collected through these tablets to ensure we have complete, consistent, and accurate datasets related to car seat checks.
  - Amy said she could get Patty connected with other state coordinators to see what kind of data they collect.
  - On October 1, 2020, a major update occurred at the National Safety Council that included clean data dashboards and incorporated feedback from CPS technicians. The next dashboard update is scheduled for January.
- Amy noted that some states have started to require the National Digital Car Seat Check Form for consistency. This has helped to streamline the data collection/reporting process.
  - Danielle Kessenger is required to report to Safe Kids and the OPRC and asked if there is a way to avoid data duplication by reporting using the Digital Car Seat Check Form.
  - Technicians should not have to submit the data separately to the OPRC if they use the Digital Car Seat
     Check Form because the state coordinators have access to that data.
  - Amy shared the digital check form and walked participants through the process for completing and submitting the form that would avoid duplication of data.
- Is there a webinar or training on the digital check form that could be posted to the OPRC website?
  - Amy would prefer to do a live webinar, record it, and post it to the website.
- Leilani asked participants to help identify ways to encourage technicians and instructors to share their data with the state.
  - Hosting regular support meetings for technicians and instructors in the state of Florida (especially now that everything is virtual) could be helpful.
  - If there is interest, Amy would be happy to coordinate and lead a quarterly meeting. She will draft an
    agenda and work with Patty to get the information out through the OPRC.
  - Leilani will share the last CPS Retention survey to help the group identify the information that could be most helpful for CPS technicians and instructors.

- Amy said there is a new Car Seat Basics E-Learning course<sup>8</sup> available for free on the Safety Council website.
- Patty mentioned the possibility of doing a presentation for the Motorcycle Safety Coalition about CPS on motorcycles.
  - Leilani said that if we continue to have virtual meetings, we may be able to have the motorcycle safety coalition provide a presentation at an upcoming FOPC meeting. She will follow up on that.
- Danny reviewed the proposed Action Plan CPS goal (Goal 3) and related objectives and asked participants if they had additional suggestions on objectives and actions that should be considered.
  - Potential Action Item: The current FOPC Action Plan does not have anything about virtual car seat checks.
     Need to consider a specific strategy or action related to digital car seat checks.
    - o Danielle Kessenger would like to do a presentation on what she has learned from other states.
    - Amy shared a link of a presentation Together we can move CPS forward<sup>9</sup> on virtual car seat check.
  - Potential Action Item: Quarterly CPS meetings.
  - Potential Action Item: Support retraining/recertification for special needs (evaluate acceptable length of time between courses, host courses, and encourage recertification).
    - Support the development of a continuing education units (CEU) process rather than a full two-day training every few years.

#### **Next Steps**

Leilani noted the following three FOPC meetings are tentatively scheduled to be held in-person in Gainesville, Florida.

- February 24-25, 2021
- June 2-3, 2021
- August 25-26, 2021

She said members will be informed about the final decision on the virtual/in-person meeting as the date approaches.
