2.0 Meeting Notes – May 22

Welcome, Introductions, and Agenda

Chris Craig, FDOT, welcomed members of the Florida Occupant Protection Coalition (FOPC) and asked each member to introduce themselves and note which agency/organization they represent. He reviewed the agenda for both days of the meeting.

Charter and Subcommittee Structure

Leilani Gruener, FDOT, said that FDOT is working on formalizing an updated FOPC Charter and subcommittee structure. She said each subcommittee (Education/Communication/Outreach; Law Enforcement; Occupant Protection for Children) would be supported by an FDOT/Consultant staff person to provide additional guidance and resources. She asked each subcommittee to identify two subcommittee leaders that would be responsible for coordinating with the subcommittee members, setting up subcommittee meetings outside of the regularly scheduled FOPC meetings, and following up with action step leaders identified in the action plan.

Action Plan Implementation – Group Breakouts

Coalition members divided into the three subcommittee groups — Education, Outreach, and Communications; Law Enforcement; and Occupant Protection for Children. Each group was instructed to discuss activities they have been working on since the last FOPC meeting, review their section(s) of the FOPC Action Plan, and update one another on progress toward achieving their assigned actions.

Strategic Action Plan Goal 1 – Education, Communications, and Outreach

Subcommittee members provided updates to their action steps and Danny Shopf, Cambridge Systematics, updated the FOPC Action Plan on-screen. A revised FOPC Action Plan can be found at <u>www.floccupantprotection.com</u>.

Occupant Protection Data Update

Dr. Michael Binder, University of North Florida, gave a presentation on a survey to Florida's safety coalitions and other partners. The survey was designed to gather information on what occupant protection materials are needed, the types

of occupant protection materials being used, and which other safety coalitions and partners are distributing those materials. He said 206 responses have been received with a large representation of responses from Safe Kids, the FOPC, Healthy Start, Florida's Community Traffic Safety Teams (CTSTs) and the Teen Safe Driving Coalition. Dr. Binder indicated that additional partner mailing lists have been identified and the survey will be sent through those channels as well. The survey also includes a section where respondents can provide suggestions for creative strategies to promote occupant protection. Coalition members had the following questions and comments:

• Consider changing the language in the survey to indicate "**car seat** checkpoints" so it is not confused with other types of checkpoints, such as DUI.

Paid Media Update

Chris Craig gave a presentation on the upcoming Click It or Ticket media campaign. He said the Click It or Ticket media campaign occurs annually during the months of May and June and includes increased education and enforcement for safety belt usage. Chris shared examples of TV commercials in English and Spanish, focused on the target audience of men ages 18-34 and secondary audiences of Hispanic men ages 18-34 and African American men ages 18-34. Chris noted that digital media, including social media, is becoming a large market for Florida's target audience and showed examples of ads that have been developed for YouTube, Facebook, and Instagram. Chris also noted that Florida uses digital billboards and variable messaging signs throughout the state to promote the Click It or Ticket message. Coalition members had the following questions and comments:

- Are we asking the universities to share this media with their students?
 - Some universities have but nothing has been formalized.

3.0 Meeting Notes – May 23

Recap of Day 1

Chris Craig provided an overview of the Day 1 discussion and outlined the Day 2 agenda.

Strategic Action Plan Goal 2—Law Enforcement Awareness of Occupant Protection

Subcommittee members provided updates to their action steps and Danny Shopf updated the FOPC Action Plan onscreen. A revised FOPC Action Plan can be found at <u>www.floccupantprotection.com</u>.

Florida Occupant Protection Resource Center Update

Jasper Masciocchi, University of Florida, provided an update on the Occupant Protection Resource Center (OPRC) including a data update on the number of and types of items ordered through the OPRC. She noted that activity books and window clings are among the most common items ordered. She also provided an update on the number of CPS professionals that are certified in Florida and the percentage of professionals that are getting recertified. FOPC members had the following questions and comments:

- FOPC Members requested the development of a pledge card to be included on the OPRC resource center website.
 - When the inventory is gone, we won't need the pledge cards to be signed anymore because participants don't need to sign for print items.
 - There are already options for pledge cards available on the OPRC website
- Could we get a more detailed report on what partners are ordering?
 - Yes, we can identify what partners are ordering and how many items they are ordering over time. This would help us figure out who we are reaching and who we need to target our outreach toward to get additional participation.
- How does car seat distribution work?
 - Car seats are available to:
 - » Technicians hosting a class (up to 6 seats at a time);
 - Technicians providing seats to families below the poverty line in priority counties (up to 24 seats at a time);
 - » Technicians having an event during CPS Week (up to 24 seats at a time) as seats are available; and
 - Technicians providing seats to families below the poverty line that were purchased through the \$2
 Difference (number of seats purchased with the \$2 Difference donations collected in that county)
 - Seats must be distributed before additional seats can be ordered
- Could we get the poverty form needed for car seat distribution in Spanish as well as English?

- Jasper will work on creating a Spanish poverty form and provide an update at the August 2019 FOPC Meeting.
- How are the counties with the highest number of donations getting the word out about the \$2 Difference?
 - Materials were developed to post in DMVs. In the past, there have been efforts to engage DMV employees and educate them about the program to encourage them to promote the program.
- Could we update the breakdown of the data to show the number of seats ordered annually with notation of which counties were priority counties each year?
 - Jasper will work on creating a summary of the number of seats ordered annually by county and provide an update at the August 2019 FOPC Meeting.

Strategic Action Plan Goal 3—Occupant Protection for Children

Subcommittee members provided updates to their action steps and Danny updated the FOPC Action Plan on-screen. A revised FOPC Action Plan can be found at <u>www.floccupantprotection.com</u>.

Hot Cars Training/Check to Protect

Amy Artuso, National Safety Council (NSC), provided an overview of the NSC and gave a presentation on children in hot cars. Amy noted the National Safety Council is focused on eliminating preventable deaths at work, in homes and communities, and on the road through leadership, research, education and advocacy. She highlighted the Road to Zero plan and associated strategies to eliminate roadway deaths by 2050. Amy indicated that the NSC has published materials about the dangers of leaving children in hot cars. Deaths to children in hot cars have occurred in all but three U.S. states during all months of the year. Amy concluded her presentation with a reminder that June is National Safety Month.

Strategic Action Plan Goal 4—Model Language to Increase Use of Occupant Protection Devices

Subcommittee members provided updates to their action steps and Danny updated the FOPC Action Plan on-screen. A revised FOPC Action Plan can be found at <u>www.floccupantprotection.com</u>.
