# 2.0 Meeting Notes - May 10, 2023

#### Welcome, Introductions, and Agenda

Danny Shopf, Cambridge Systematics, welcomed participants to the Florida Occupant Protection Coalition (FOPC) meeting and thanked everyone for joining. He noted a few members joined the meeting virtually which is set up to be listen-only. He asked attendees to introduce themselves. Following introductions, Danny reviewed the agenda.

#### **FOPC Strategic Action Plan Subcommittee Breakout**

Coalition members split into subcommittee groups organized around each goal of the Strategic Action Plan. The subcommittee groups reviewed the action steps for their respective goals. Action step leaders provided updates on their progress via email following the meeting.

## **Legislative Updates**

Chris Craig, FDOT, provided a brief overview of legislative activity related to occupant protection.

Participants had the following questions and comments:

#### **SB 1374 - Child Seat Requirements**

- Bill would increase the age requirements and positioning. There were bills in both the Senate and House but it ultimately died in Senate Rules Committee.
- There was a reference to a 5-point harness but that may be a little restrictive based on innovations in car seat technology.
- We have a contact that played a major role in writing the recently drafted language so we can share our model language with him.
- Will review the existing model language at the next FOPC Meeting.



#### HB 949 - Golf Carts

- The Governor has signed a bill that increases the age restriction for golf carts from 14 to 16. There are also conversations about requiring at least a learner's license to operate a golf cart.
- There is still a lot of confusion around golf carts, where they can be operated, and who can operate them. This challenge is exasperated because local ordinances are not always consistent.

#### Click It Or Ticket Media Update

Chris Craig, FDOT, gave a presentation on the Click It Or Ticket (CIOT) Media campaign. He reviewed the CIOT timeline, including the paid media campaign and the enforcement campaign, both taking place in May and June 2023. Chris noted an observational survey is conducted following the CIOT campaign along with a CIOT Awareness survey.

Chris reviewed the paid media campaign strategy, highlighting the target audience of young males (age 18-34) in all 10 of Florida's Designated Media Markets (DMAs). The paid media campaign will include television and cable, digital video (Hulu, YouTube, Univision, Samba TV, Vizio), radio, digital audio (Spotify, Pandora, SoundCloud). He said the media is also focused on social media, including Facebook, Twitter, and Snap Chat. He shared examples of the advertisements that will be included in the paid media campaign. Chris said there will be about 175 billboards across the state that will promote the COIT message and Florida has started partnering with transit agencies to put the COIT messaging on transit vehicles around the state. Finally, he shared the video message that is shared on Gas Station TV. In total, Florida is spending \$1.7 million to get an estimated 84 million impressions.

Chris also highlighted CIOT messaging on dynamic message signage (DMS) on Florida's roadways that promotes CIOT. He said Florida's LEL team coordinates with Florida's law enforcement agencies to encourage participation in the CIOT. On average, 240 law enforcement agencies participate and report information back to the LELs.

Participants had the following questions and comments:

- While not all law enforcement agencies are reporting their enforcement numbers, there are many
  agencies that participate in the CIOT enforcement wave that do not have the bandwidth to track and
  report those numbers.
- How do we get banners, yard signs, etc. to support CIOT?
  - The LELs have them and many of the CTSTs have access to them as well. Feel free to reach out to them to get as many as you need.
- There are law enforcement awards for officers that conduct extensive DUI enforcement. We should consider doing the same for occupant protection.
  - We do offer an award for officers and agencies that do extensive occupant protection enforcement during the CIOT campaign.
- The English and Spanish ads had a different focus. Was there a reason for that?



 Yes. NHTSA does a lot of focus testing and each of these ads resonated better with the target audiences. Each took a slightly different approach on how an unrestrained fatality or injury can impact one's family.

# 3.0 Meeting Notes - May 11, 2023

#### Recap of Day 1

Danny Shopf, Cambridge Systematics, welcomed participants and thanked everyone for attending Day 2 of the FOPC meeting. He gave a brief recap of Day 1 and reviewed the Day 2 agenda.

#### **Special Needs Child Passenger Safety**

Petra Stanton, John's Hopkins All Children's Hospital, gave a presentation on special needs child passenger safety. She noted there is some discourse about changing the terminology from "special needs" to "adaptive needs." She said the Safe Travel for All Children (STAC) program is an enrichment program to the National Child Passenger Safety Certification training and the gold standard curriculum in the U.S. The curriculum covers common medical conditions impacting transportation and the car seat options to accommodate those special medical conditions. Some examples include car beds and rear facing alternatives for children with low birth weights or other conditions such as spina bifida, casts, etc. She noted the preferences is always to try a conventional car seat first.

Petra also noted there are large medical seats for children that have outgrown conventional car seats but cannot sit unassisted. These are for long-term medical conditions, such as cerebral palsy. Other options for larger/older children include adaptive booster seats, vests, and wheelchairs.

Petra noted the STAC course was held in St. Petersburg, FL in 2022 and was very well received. She noted Florida has 3 STAC instructors and a mentor from an approved program is required for instructor certification, which can be challenging. In the future, it would be good to have an annual STAC training, perhaps in coordination with Kidz in Motion.

Participants had the following questions and comments:

- Is a recertification required for the special needs training?
  - To become an instructor, candidates need to retake the training. It is not required otherwise, but it is recommended to retake the course regularly.
- What are the costs associated with the STAC training?
  - Most programs throughout the U.S. collect a fee. The agency that is hosting the training incurs
    the cost of materials, etc. and those fees are typically used to pay for those materials. This fee
    also helps to discourage those that don't actually need the training.
    - FDOT can help with the printing of training materials to help offset the costs to the agency.
  - There are also challenges with getting access to and storing the special needs demonstration seats and dolls specifically for these trainings.
- Where can we get information on these seats or other restraint devices?



- o Petra and Danielle Kessinger can provide more information on these options.
- It is always recommended to go to a clinic that has access to a medical professional (physical therapist, occupational therapist, etc.) who can provide a letter of medical necessity which will qualify them for a seat/restraint option that insurance will likely cover.
- What is the student-teacher ratio for these courses?
  - It is not as clearly stated as normal CPS Technician training course. Practically, it is difficult to work with more than five or six students per instructor.
- Does the course include a skills test and a training test?
  - Yes, this is how the course is formatted.

#### Law Enforcement Safety Belt Use Survey Results

Charles Kane, LEL Program, gave an update on the law enforcement safety belt use survey results. He said the most recent survey had 317 responses from law enforcement officers throughout the state. He said the survey is completely anonymous to encourage officers to answer honestly.

Survey questions were designed to gather information about law enforcement officer location (LEL Region level), experience, whether officers are wearing their safety belt on and off duty, their reasons for not wearing a safety belt, and the officer's normal response to safety belt and child restraint violations. The survey also includes a question about diversion programs and a section of "Did you Know?" questions providing officers with facts about safety belt usage as an educational opportunity.

Participants had the following questions and comments:

- How do this year's results compare to past surveys?
  - The results were about the same as prior years.
- It is important to address safety belt usage early in the law enforcement training programs. It is easy to
  tell which officers are regularly wearing their safety belt and trainers need to reinforce the importance
  of practicing getting into and out of their vehicle with their safety belt.
- Consider adjusting the question about "How does a safety belt affect officer safety" to make it clear this is related to when an officer is involved in a crash.

#### **CPS Fitting Station Website Update**

Jason Rogers, University of Florida, gave a presentation on the CPS Fitting Station website – <a href="https://www.flchildseatsafety.org">www.flchildseatsafety.org</a>. The purpose of the website is to connect families with child passenger safety fitting stations. The website is an interactive map-based tool to help families, CPS professionals, and law enforcement officers identify locations of CPS fitting stations.

The team has also created an Accessible Tip Card that includes important information about the website and how to use it to help promote the website. Soon, the team will be conducting an email campaign to promote



the website to key stakeholders and community partners throughout the state. He asked the FOPC provide any contact information they can share and forward the email to others in their own contact list.

Participants had the following questions and comments:

- Will you share a copy of the QR Code to include our own websites?
  - o Yes, we can provide after the meeting.
- How was the information in the tool collected and populated?
  - Initially, this information was provided by the OPRC but there are clearly some gaps that need to be filled. We are relying on members of the FOPC to help us fill those gaps and capture all of the CPS fitting stations available in Florida.
  - There is an "Add Your Station" link that is being updated and will be a good tool for collecting additional information on available CPS fitting stations.
- What is the best way to get a station that is no longer active removed?
  - o It's probably best to send those requests via email

#### **Occupant Protection Materials Review**

Chris Craig, FDOT, reviewed updated character options to include the in the Child Passenger Safety Coloring Book under development. He noted these characters were presented at a prior FOPC meeting and have been revised by the designers based on feedback from the coalition.

Participants had the following questions and comments:

- Ensure the safety belt paths are accurate and appear tight.
- Ensure each seat has a clear five-point harness and an appropriately placed chest clip.
- Consider adjusting the image so that it is clear the window is closed and the alligator is not holding his arm/toy out the window.
- The mother alligator's proportions seem incorrect. Consider revising her seating position to make it seem less awkward.
