2.0 Meeting Notes – September 2-3

Welcome, Introductions, and Agenda

Chris Craig, Florida Department of Transportation (FDOT), welcomed attendees to the Florida Occupant Protection Coalition (FOPC) meeting and thanked everyone for joining the second virtual meeting of the Coalition. He asked attendees to introduce themselves and began the meeting.

Law Enforcement Survey Update

Charles Kane, Florida Law Enforcement Liaison (LEL) Program, shared an overview of the Law Enforcement (LE) Occupant Protection (OP) August 2020 survey results. He noted adjustments were made to the LE 2020 survey questions based on the feedback received in a prior FOPC meeting. Of the 629 responses, 89 percent of the officers wear a safety belt off duty, while 74 percent wear a safety belt on duty. Respondents who did not wear a safety belt while on duty were asked to write in the reason why. Responses included several suggesting the safety belt restricts ability to respond in emergency situations, blocks access to their firearm, and is difficult to manage while wearing an outer vest. Seventy-three percent of the officers believe a training video or presentation on safety belt and child restraint enforcement would be helpful. Additional suggestions included more educational campaigns, lower violation fees, and additional training materials. Charles noted the feedback on materials and tools will help identify measures

to increase the safety belt usage rate among the LE officers. Detailed survey results are posted to the FOPC website¹ under Meeting Materials.

Coalition members had the following questions and comments:

- Chris recommended to start with advertising and educating LE officers for post-COVID-19 enforcement activities.
 He suggested coordinating with consultants or LELs who have presentation/video making skills to develop educational videos and materials.
- Look for some educational videos to provide to LE officers.
 - International Association of Chiefs of Police (IACP) is working on updating the Saved by the Belt promotional videos. Tim Roberts, Florida LEL Coordinator, should be able to share updates on educational videos available on the LEL website next FOPC meeting.
- Are there mandatory diversion programs available that allow for a low-cost car seat to be distributed to participants? This might reduce hesitation of LE officers to issue citations for child restraint violations.
 - Miami-Dade County has a 90-minute diversion program² for child restraint violations. Completion of this
 program might waive or lower the penalty and reduce points against the offender's license.

Legislative Update: Safety Belt and CPS Restraints

Danny Shopf, Cambridge Systematics, shared draft model legislative language regarding safety belt and child passenger safety (CPS) restraints. He asked members to reach out if they have any connection with a partner/agency who can help drafting the identified model language.

Safety Belt Usage:

Danny shared the current Florida Safety Belt use law and asked members to review the proposed model language updates and share their input.

Florida Statute 316.614-

(14) It is unlawful for any person:

- (a) To operate a motor vehicle or an autocycle in this state unless each passenger and the operator of the vehicle or autocycle under the age of 18 years are restrained by a safety belt or by a child restraint device pursuant to s. 316.613, if applicable; or
- (b) To operate a motor vehicle or an autocycle in this state unless the person is restrained by a safety belt.

(15) It is unlawful for any person 18 years of age or older to be a passenger in the front seat of a motor vehicle or an autocycle unless such person is restrained by a safety belt when the vehicle or autocycle is in motion.

Coalition members had the following questions and comments:

- Ideally, the safety belt law should be applicable to all seat positions for all ages. Eliminate/change the pickup truck rule that allows kid to ride on a pickup bed.
 - Remove "front seat" from point 316.614 (15) and replace that with a "passenger seat of a motor vehicle".

- Does the existing statue reference a safety belt law for automated vehicles? The coalition should evaluate existing legislation to ensure safety belt laws remain applicable for automated vehicles.
 - Gregory Rittger, Orange County Sheriff's Office, shared that there was an automated vehicle test on Florida's
 Turnpike. He said in that case, when an autonomous vehicle is in self-driving operation, the person in that
 vehicle will be considered the operator for purposes of insurance, etc.
 - Need clarification on who would be considered the driver/operator, when there is no one in the automated vehicle.

CPS Restraint Law:

Danny shared the current Florida Child Restraint use law and reviewed aspects of the existing law that could be adjusted. He asked members to review the proposed model language updates and share their input.

Florida Statute 316.613-

(1) (a) Every operator of a motor vehicle as defined in this section, while transporting a child in a motor vehicle operated on the roadways, streets, or highways of this state, shall, if the child is 5 years of age or younger, provide for protection of the child by properly using a crash-tested, federally approved child restraint device.

- 1. For children aged through 3 years, such restraint device must be a separate carrier or a vehicle manufacturer's integrated child seat.
- 2. For children aged 4 through 5 years, a separate carrier, an integrated child seat, or a child booster seat may be used. However, the requirement to use a child restraint device under this subparagraph does not apply when a safety belt is used as required in s. 316.614(4)(a) and the child:

Coalition members had the following questions and comments:

- Louisiana child restraint law does not specifically mention age, weight, or height. The law has good language and could be a starting point for drafting a model language for Florida.
 - From LE standpoint, it is easier for the officers to enforce the child restraint law when it mentions age. Law specification with weight might create challenges for the officers to enforce.
- Tennessee child restraint law has exemption for kids with special needs. If this is not incorporated in the current Florida legislation, we can think about including that in the model language. There should be child restraint legislation that include considerations for day care places transporting children.
- Florida House Bill 533 legislation proposing a change in the child age requirement (through age 6) for safety seat usage did not pass in early 2020.
- Amy Artuso, National Safety Council, noted American Academy of Pediatrics recommend all children under age 13 to ride on the rear seats of a vehicle. For Florida legislative model language, consider proposing to change the age requirement to 6, though it is challenging. Amy also shared the following resources from the Governors' Highway Safety Association (GHSA): Child Passenger Safety³ and State Laws on Child Passenger Safety⁴.

Danny thanked the attendees for their valuable input and noted he will regroup with Chris Craig and Leilani Gruener, FDOT, to put together some suggestions based on the feedback received and share the draft model language with the Coalition for review.

FOPC Strategic Action Plan Update (2021)

Danny thanked coalition members for their diligent work in achieving many of the actions identified in the existing FOPC Strategic Action Plan. He indicated that the action plan is due to be updated in 2021 following the update of the Strategic Highway Safety Plan (SHSP) and Occupant Protection Assessment. To prepare for the action plan update, he said staff have proposed an adjustment to the structure of the FOPC Strategic Action Plan Goals and supporting subcommittee groups. He presented the following proposed action plan goals:

- Goal 1: Establish a sustainable infrastructure that provides leadership, funding, data, policy and evaluation for occupant protection.
- Goal 2: Establish a collaborative effort to provide statewide direction and focus to improve law enforcement awareness of occupant protection.
- Goal 3: Establish a collaborative effort to provide statewide direction and focus for child passenger safety.
- Goal 4: Establish a collaborative effort to provide statewide direction and focus for occupant protection for low use groups.

Danny highlighted a major reason for this change was that the Education/Communications/Outreach component of the action plan was often duplicated across several existing goal areas and there was a lack of emphasis on safety belt usage among the state's lowest use groups. In the proposed structure, Education/Communication/Outreach will be incorporated specifically into each of the proposed goal areas (law enforcement, child passenger safety, and occupant protection for low-use groups).

Danny reviewed the proposed four goals for the upcoming Action Plan update and asked members if any elements are missing from the proposed approach. He emphasized these are high level overview of the proposed goals and objectives and will be adjusted as input received from the Coalition members.

Coalition members had the following questions and comments:

Zakkiyyah Osuigwe, Santa Rosa County Development Services, said the proposed goals are broad and will enable
us to concentrate on different focus areas.

Danny noted we will discuss more about the proposed goals and supporting objectives with each of the subcommittees during the group breakout sessions and will be coordinating with the Coalition members in the future meetings before finalizing the update. He reminded attendees to reach out if they have any suggestions on the goal language.

3.0 Action Plan Implementation – Group Breakouts

Three separate virtual meetings were conducted for each of the three group breakout sessions- Education, Communication, and Outreach; Law Enforcement; and Occupant Protection for Children.

The following sections include meeting notes from the three breakout sessions. A revised FOPC Action Plan is attached as an Appendix of this summary report and can also be found at www.floccupantprotection.com.

Strategic Action Plan Goal 1 – Education, Communication, and Outreach

Subcommittee members conducted a breakout session on September 3, 2020, to discuss activities they have been working on since the last FOPC meeting, and review their section(s) of the FOPC Action Plan. Danny updated the Action Plan on-screen.

Coalition members had the following questions and comments:

- Need to focus on digital outreach and distribution to track number of people visiting the Florida Occupant Protection Resource Center⁵ (OPRC) website, downloading materials, etc.
 - Patty Turner, University of Florida, has the information on digital tracking, can get this information to the Coalition, if needed.
- Has the state facilitated outreach related to the Florida Saved by the Belt campaign?
 - Yes, Florida LELs are promoting Saved by the Belt initiatives statewide. David Summers, Trauma Agency,
 Health Care District Palm Beach County, will reach out to Charles offline to talk more about this program.
- Need to review the OPRC to list the materials that should be featured and promoted. Also consider rebranding some materials to better suit the digital platform.
 - Andrea Atran, FDOT (District 2) and David will take a look at the OPRC and flag some materials those need to be promoted and will also share any materials they would like to suggest for the resource center.

Proposed Objectives for FOPC Action Plan Update

Danny recapped the proposed FOPC Strategic Action Plan goals and shared the idea of including Education/Communication/Outreach components in each of the proposed goals. He suggested a new subcommittee focusing on safety belt usage for low-use groups should be created. Danny asked the members to share their thoughts and concerns related to the proposed restructuring of the action plan and new subcommittee area. He also reviewed the identified low use groups under Goal 4 (presented as follows) and asked members to share some high-level objectives that should be prioritized to advance this goal.

- Goal 4: Establish a collaborative effort to provide statewide direction and focus for occupant protection for low use groups.
 - Males Ages 18-34
 - Pickup Truck Drivers
 - Minority Populations

Coalition members had the following questions and comments:

- CPS and LE Subcommittees should focus on low-use groups as well.
 - Danny replied LE awareness of OP goal includes an objective of data-driven enforcement that would involve minority groups.
 - It would be beneficial to integrate occupant protection and enforcement. Might want to have outreach/material development component under each goal.

- Members shared mixed opinions about the specific reference to low-use populations in the proposed goal language. Members recommended to draft objectives/action steps related to overall safety belt usage that would include older driver, teens, etc.
 - Might consider having an additional task force/committee to support the low use group. Alternatively,
 consider referencing safety belt and air bag usage rather than focusing specifically on low-use groups.
- Goal 1 incorporates data work and each subcommittee is working on data to some extent. Might need to have a separate subcommittee group on focused on occupant protection data.
- Along with the crash data (Florida Charts), ensure public health/trauma centers, emergency run data, trauma data, etc. is evaluated and integrated in the decision-making process.
- Leilani reported that the FDOT Highway Safety Plan identifies similar low-use populations. Targeting our efforts on our lowest use populations may help better demonstrate our use of federal grant funding.
- Where does all-terrain vehicle (ATV) fall in hierarchy within the Coalition?
 - Andrea has some ATV materials, will share that with the Coalition.
 - ATVs and golf carts should be part of this coalition in terms of OP. Leilani added, we cannot do golf cart for OP. However, Safe Mobility for Life has recently worked on a Golf Cart brochure specific to older adults, available online through the Safe Mobility for Life Resource Center⁶.

Danny emphasized that the subcommittee's input will be taken into account and the updated version will be shared with the subcommittee at the next meeting.

Strategic Action Plan Goal 2—Law Enforcement Awareness of Occupant Protection

Subcommittee members met for their breakout session on September 3, 2020, to discuss activities they have been working on since the last FOPC meeting and review their section(s) of the FOPC Action Plan. Danny updated the Action Plan on-screen.

- Leilani shared the following two references to help the subcommittee get started on calculating economic cost of injuries (for Action Step 3.1D). Guide to Calculating Cost⁷ and CDC: Cost Data and Prevention Policies⁸.
 - Andrew Hopkins, University of North Florida, offered to assist the LE subcommittee in calculating economic cost of crashes.

<u>Proposed Objectives for FOPC Action Plan Update</u>

Danny reviewed the proposed goal related to LE awareness of OP for the FOPC Action Plan update and shared some high-level objectives to support that goal. He noted the proposed objectives covered everything from the current action plan and asked the subcommittee members identify aspects that may be missing. The proposed LE awareness goal (Goal 2) and supporting objectives are as follows-

• Goal 2: Establish a collaborative effort to provide statewide direction and focus to improve law enforcement awareness of occupant protection.

- Obj 2A. Increase safety belt usage among law enforcement officers.
- Obj 2B. Increase law enforcement officers' ability to identify child restraint usage problems and solutions.
- Obj 2C. Increase law enforcement officers' ability to identify common restraint use problems and solutions for aging road users.
- Obj 2D. (Option A) Provide law enforcement agencies with resources to conduct outreach, education, and high-visibility enforcement in areas with high incidence of occupant protection-related injuries and fatalities.
- Obj 2D. (Option B) Increase law enforcement awareness of external resources available for occupant protection.

Coalition members had the following questions and comments:

- Objective 2B will include the scope of partnering with CPS occupant protection challenges.
- For Objective 2D, members suggested: "Provide LE agencies with resources to conduct outreach, education and data driven high-visibility enforcement".
- Consider drafting action items based on the LE survey results and consider adding more training materials to the website.
 - Petra Vybiralova, Johns Hopkins All Children's Hospital, offers a course for parents and caregivers where they have educational videos to promote child safety⁹. We might encourage the court to look at those educational videos.
- Tim shared some statistics on recent child restraint citations. He volunteered to track the child restraint citation data by County in Florida and identify the top three counties of the seven FDOT districts.

Danny thanked everyone for their input and will make edits to the proposed objectives as suggested. He said the subcommittee will have an opportunity to talk about detailed actions at the future meetings.

Strategic Action Plan Goal 3—Occupant Protection for Children

Subcommittee members met for their breakout session on September 2, 2020, to discuss activities they have been working on since the last FOPC meeting and review their section(s) of the FOPC Action Plan. Danny updated the Action Plan on-screen.

- CPS technicians are doing virtual car seat checks. The caregivers use Facetime, Skype, Zoom, Google duo, Facebook messenger, Webex etc. whatever application they are comfortable using.
 - Petra explained the process how they offer virtual car seat education. She also shared a resource on CPS safety¹⁰ that they have been sharing with their clients.
 - Amy asked to share any feedback on virtual class or course curriculum on www.cpsboard.org.

- Add Safe Kids profile on OPRC, if they are offering virtual checks. Identify instructors/technicians who are comfortable doing virtual checks and get technician proxy set up.
- Amy shared a reference of CPS resources¹¹ across different states.
- Patty and Jasper will develop a survey to see who is conducting virtual sign-offs, and have Danielle Kessenger, The PLAYERS Center for Child Health at Wolfson Children's Hospital, Sarah Haverstick, Goodbaby International and Petra to review the questions.

Proposed Objectives for FOPC Action Plan Update

Danny shared proposed goals for the FOPC Action Plan update, highlighting the goal related to CPS. He also reviewed the proposed objectives and asked members if there are any concerns with this approach and if there are any gaps in the list that need to be prioritized for the next five years to support the CPS goals. The proposed CPS goals (Goal 3) and supporting objectives are as follows:

- Goal 3: Establish a collaborative effort to provide statewide direction and focus for child passenger safety (CPS).
 - Obj 3A. Increase the quantity, quality and retention of certified CPS technicians (CPST) and instructors (CPST-I).
 - Obj 3B. Increase availability of CPS resources and materials.
 - Obj 3C. Support mandatory diversion programs for first-time child restraint offenders.
 - Obj 3D. Increase the quantity, quality and retention of certified Special Needs CPS technicians and instructors.

Coalition members had the following questions and comments:

- Switch Objective 3D and 3B, so that they are in a more logical order.
- Reword Objective 3C to emphasize the establishment of a standard and best practice curriculum for a statewide diversion program and to support mandatory diversion program for first time child restraint offenders.
- Leilani reminded participants about developing best practices for CPS model legislation. She emphasized following manufacturer guidelines to suggest an increase in the child age for safety belt restrained.
 - Jasper Masciocchi, University of Florida, asked the scope of revising the penalties while reviewing the CPS legislation.
 - » We can certainly look at that. Before suggesting any changes to the penalty, it would be beneficial for the CPS group to identify what diversion programs are available across the state, and what an ideal diversion program should include. Might also want to see if National Safety Council is willing to increase their roll in this.
 - Identify counties with high rates of safety belt and/or CPS citations to identify potential locations for diversion programs.
